

## 12 DAYS OF FITNESS ONNIT INSTAGRAM GIVEAWAY

### OFFICIAL RULES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. ELIGIBILITY:** The 12 Days of Fitness Onnit Instagram Giveaway (“Giveaway”) is open to legal residents of the United States. Entrants may not be members of any guild, union, or other organization that may prohibit them from participating in this Giveaway or that would restrict, require due payment, or otherwise have the right to oppose such Entrant’s participation in this Giveaway. Directors, Officers, Employees, Agents, Independent Contractors and Shareholders of Onnit Labs, Inc. and/or its subsidiaries, and their immediate family members (including spouses, parents, siblings, children, and their respective spouses) and/or those living in the same household of each are not eligible. The approximate retail value (ARV) of the Grand Prize is approximately \$3,409.00 USD depending on the value of shipping for the Grand Prize Winners.

The Winners will be contacted via Instagram. If Sponsor does not receive a response from Winner within twenty-four (24) hours of Sponsor’s notification to Winner, or the Winner declines the prize or fails to meet Sponsor requirements, such Winner may be disqualified, and the prize will either be forfeited or awarded to an alternate entrant. Sponsor’s decisions will be final and binding in all matters related to the Giveaway. Sponsor does not make any warranty, representation, or guarantee, express or implied, in fact or in law, relative to the use of any prize, including, without limitation, quality, merchantability, and fitness for a particular purpose. Entrant agrees that Sponsor has the right to substitute any prize of equal or greater value within their sole discretion. All decisions of Sponsor shall be final, binding and non-appealable. **15. GOVERNING LAW; JURISDICTION:** This Giveaway will be governed by and construed in accordance with the laws of the State of Texas without regard to conflict of law principles.

**16. Rules and Procedures (provided such location is reasonably convenient for Entrant), or at such other location as may be mutually agreed by the Entrant and Sponsor; (4) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the Entrant may have entered into in connection with the Giveaway; (5) the arbitrator shall apply Texas law consistent with the FAA and applicable statutes of limitations, and shall honor claims of privilege recognized at law; (6) there shall be no authority for any claims to be arbitrated on a class or representative basis as Entrant and Sponsor hereby waive the right to assert claims in any class or representative action; arbitration can thus decide only the Entrant's and/or Sponsor's individual claims; the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated; (7) to the extent permitted by law, the arbitrator shall not have the power to award punitive, incidental or consequential damages against the Entrant or Sponsor; and (8) if any part of this arbitration provision is deemed to be invalid, unenforceable or illegal, or otherwise conflicts with the Rules and Procedures established by AAA, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein.
